Established operating reserves.

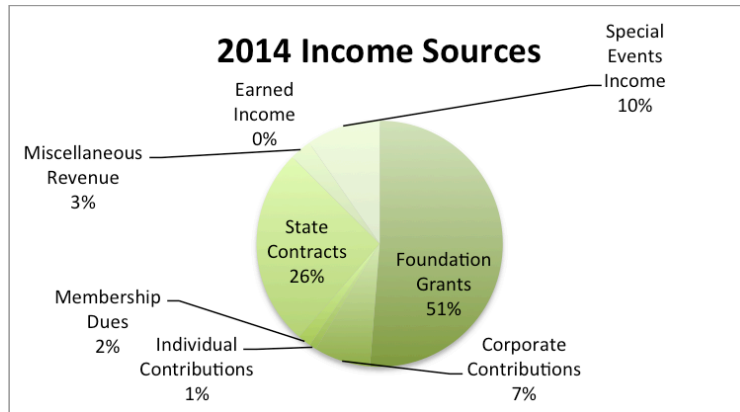
