


- Enrolled 264 new healthcare volunteers and 5 safety net sites in the Volunteer and Retired Providers Program.
- Secured \$1.6M to fund free clinic operations through<u>ESHB 1368</u>, distributed in August.
- Successfully advocated for free clinic funding eligibility in the<u>revised</u> <u>Washington State budget</u>, to be distributed in 2022.
- Completed and published the <u>Washington State Primary Care Needs</u> <u>Assessment</u> in collaboration with the Area Health Education Center for Western Washington.
- Implemented a shared Volunteer and Retired Providers Program survey process with the National Association of Free and Charitable Clinics.
