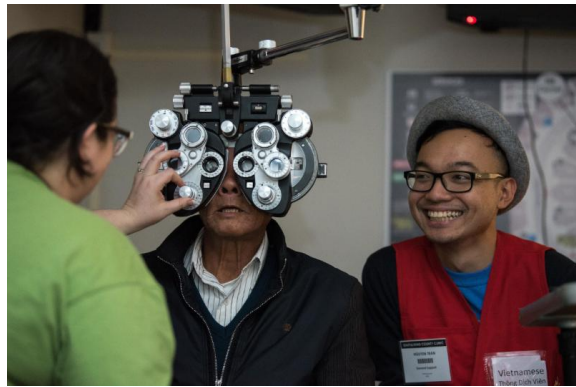


2018 | Year in Review

- Developed new survey mechanisms, and collected Volunteer and Retired Providers Program site and volunteer data from 2016 and 2017
- Enrolled more than 600 new healthcare volunteers and 12 sites for participation in the Volunteer and Retired Providers Program
- Engaged a larger number of conference partners than in any previous year
- Developed and implemented an all-electronic malpractice application for the Volunteer and Retired Providers Program
- Increased grant funding by more than 90% over the previous year

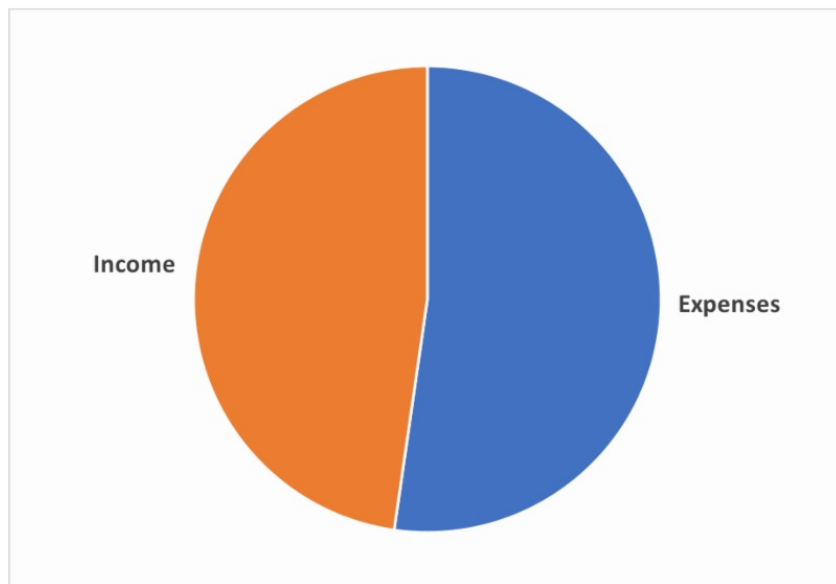
